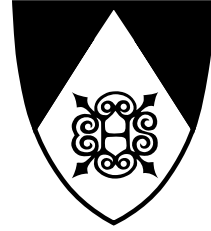

## STEPHEN '77 AND SUSAN HIRD EAA Athletic Hall of Fame

Steve and Sue both earned undergraduate degrees at UW-Madison, Steve in finance and Sue in retail management. Steve worked as a financial management analyst for General Mills for several years before moving to Piper Jaffray where he was a financial advisor and managing director for his 21 years with the firm. In 2006 Steve moved his practice to Morgan Stanley where he was an executive director and financial advisor. He retired this past spring. Sue worked in recent years as a development assistant at Gilda's Club Madison and as an administrative assistant at Madison College.

Sue and Steve have been very involved in volunteer activities, including joining the Edgewood Athletic Association Board from 2005 to 2010. Sue served with the Madison Junior Women's Club from 1987 to 1995 and was the organizations president in 1991. She was a member of the EHS Auxiliary, 2008-2010 and headed it up in 2009. She served on the Board of Nakoma Golf Club Women's Organization for six years, leading it as president in 2004. She says of her commitment, “Catholic secondary school education is important and life-changing. ## THOMAS REMINGTON '68

Dominican Award for Service to Humanity

Tom's entire career has been devoted to helping others and sharing his knowledge to help solve problems. He says, "It is clear that what I retained from Edgewood is the value of study and the importance of learning. In my personal life, it would be itinerancy, going where I need to go and where I feel I am needed — investing in African farmers and agriculture."

Tom graduated from Edgewood at a tumultuous time in our nation. He says, "Martin Luther King was assassinated on April 4, Robert Kennedy on June 6, and I was drafted on November 18. I survived." Tom completed a BSc and MSc in horticulture and a PhD in agronomy at UW-Madison.

Then, as Fr. Samuel Mazzuchelli said, he "...set out for any place where the work is great and difficult." Tom has worked with African farmers since 1977 when he joined the Peace Corps and served in northern Mali. Over a span of 40 years, he and his family have lived and worked in Mali, Togo, Gambia, Cote d'Ivoire, Kenya, Burkina Faso, Burundi and Malawi. Tom was with Catholic Relief Services for 19 years before retiring as the principal agriculture advisor. He also worked for UW-Madison, the AfricaRice Center and the International Potato Center.

Tom's expertise and interest is in seed systems and seed security, especially rice cropping systems and staple crop value chain development. He developed an approach using vouchers to assist disaster-affected farmers in accessing seed that has been widely adopted. Rather than simply dropping tools and seed into the country as relief, farmers make choices and learn about markets, placing them at the center of their own recovery. Tom authored or co-authored several articles on agriculture in Africa and authored a five-module eCourse on Seed Systems and Natural Disaster Management for the World Bank.

Now a short-term consultant, Tom also served as a member of the Collaborative Crop Research Program Advisory Committee. His wife, Debra Shomberg, is currently the Catholic Relief Services Balkans representative in Sarajevo, Bosnia. They have three children, Neal, Claire and Paul.

Mazzuchelli Award for Service to Christian Education

Dedicating one's life to a single career in a single place requires the kind of commitment few of us are able to muster. Cathy Van Gemert Spengler is an exemplar of that focused devotion in the field of education, perhaps reflected in a verse from Proverbs that she quotes: "Start children off on the way they should go, and even when they are old they will not turn from it."

After earning a BS in education with a history minor from Edgewood College in 1972, Cathy took a position as a middle school teacher at Blessed Sacrament School, where she has worked for 47 years. About her belief in the value of Catholic schools based in her personal experience, Cathy says, "The Dominican values of Truth, Compassion, Justice, Community and Partnership have influenced me and are evident in my life today. As my parents made sacrifices to send me to Edgewood High School, I have made sacrifices to send my children there to have these values developed in them (Sarah '98, Thomas '00 and Maria '03), as well."

Cathy brings those values into her own classroom, saying, "I preach them through my actions daily as my students and parents challenge me to stay true to them." She also lives them out as a volunteer at Grace Episcopal Men's Shelter, providing community outreach. Cathy also worked on developing curriculum for the Diocese of Madison.

Former Blessed Sacrament principal Maryann Slater says, "Cathy has always displayed a strong work ethic, creativity, and a commitment to excellence (after attending 11:00 mass, she has spent many a Sunday afternoon in her classroom preparing for the coming week!). She has accepted new teaching assignments over the years, and is always willing to step in where needed."

Cathy also puts in extra time to plan field trips, invite guest speakers, and give students an opportunity to write about their personal experiences. She guides her sixth graders in hosting the annual Renaissance Faire over which she reigns as queen with grace, a delightful learning experience for the younger students at BSS!

Current principal Steve Castrogiovanni says, "Cathy is a wonderful teacher who has dedicated her life to our Catholic school. She is a true master of her craft and is always searching for new ways to prepare her students to succeed in our ever-changing world, while also keeping Jesus and his teachings at the center of everything."

An observation shared by both Steve and Maryann is that Cathy has always believed that students learn through experiences. John Flesch was a third generation Edgewood High School graduate, and graduated in 1969. John met the love of his life, Jeanne Stalker, while working with at-risk children at a non-profit organization called Browndale. Ed Murphy, a friend of John's, left a message on the obituary memory page. "John and I were high school classmates at Edgewood and coincidentally have both been golf members at Nakoma since 1996. John was very successful in business, but that was the least of his many accomplishments. He did a lot in his lifetime through his dedication to his community and many charitable good works."

Damon Busse, a caddy and golf operations employee at Nakoma, noted, "John was truly one to emulate for his kindness and respect for others, regardless of their role." Business clients remember being made to feel like the most important person to him when you spoke or met.

John and Jeanne enjoyed spending time with family and friends and they traveled extensively on trips around the world. Their children—Jessica '95, Eric '98 and Amy '00—all attended Edgewood High School and the Flesches were strong supporters of all their children's activities, including athletics and the arts.
